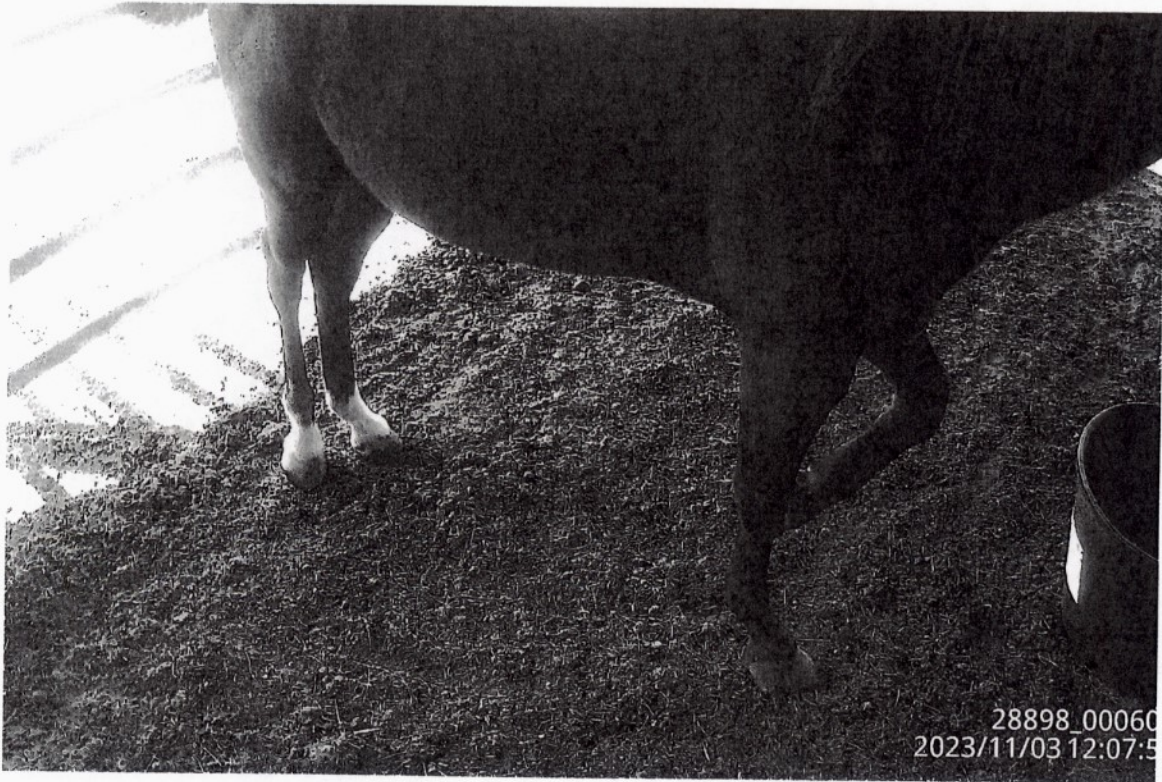

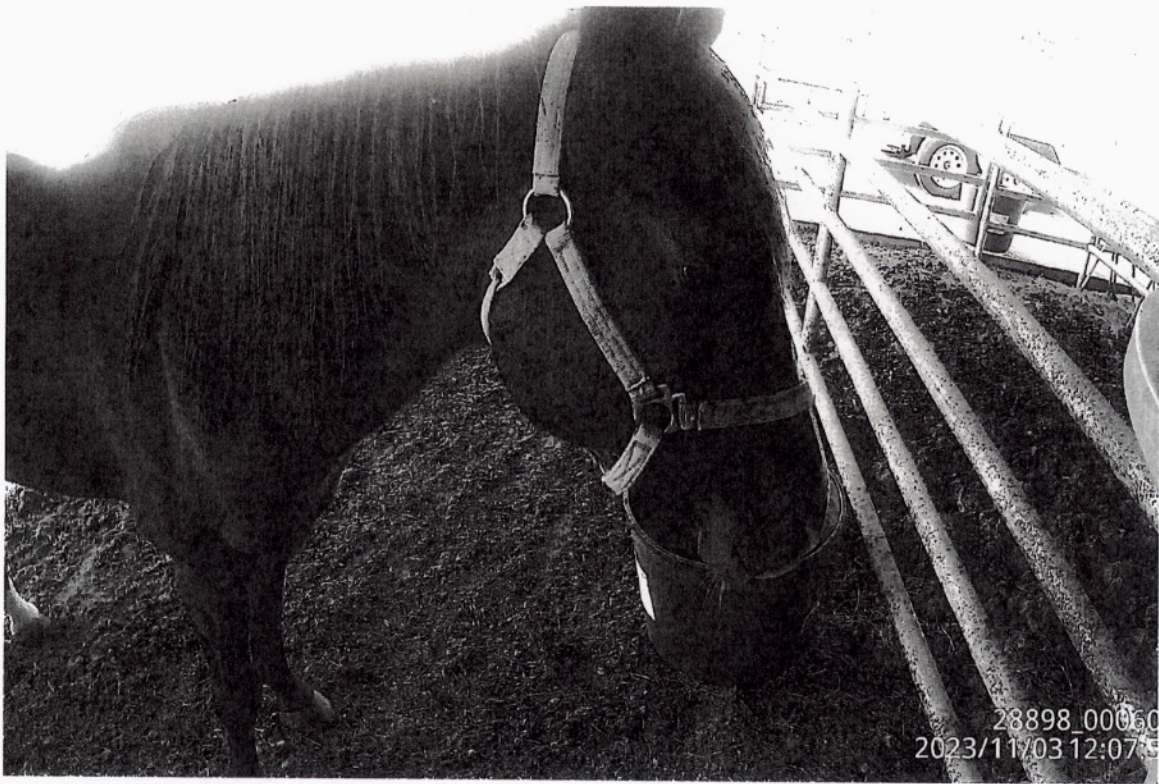
REPORT INFORMATION

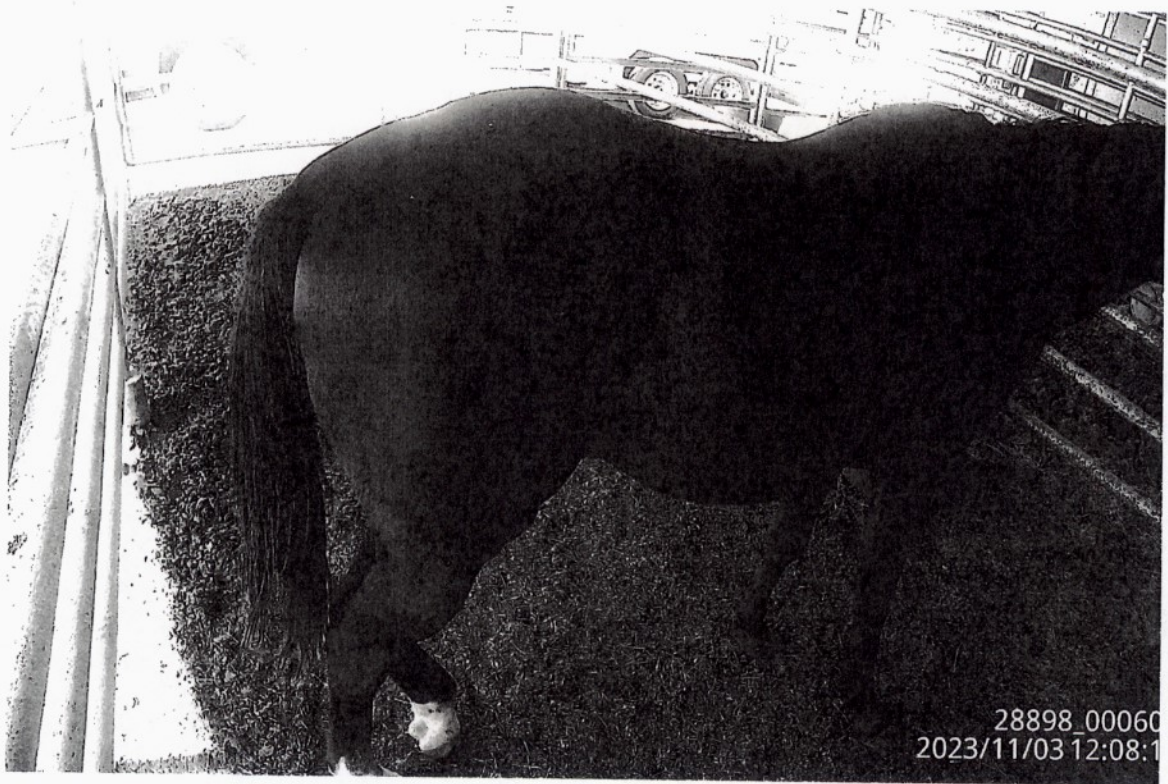
1. On Tuesday 10/31/23 at approximately 9:20 p.m. Deputy Paiz with the San Patricio County Sheriff's Department was sent to the area of FM 631 and Hwy 188 in Taft Texas 78390 for a call of a Horse in the road.
2. On the way Deputy Paiz located the Horse at the intersection of FM 631 and CR 1258. Deputy Paiz noticed the horse was trying to get in a fenced in area where there were other horses. Deputy Paiz went to the house that was connected to the property, which was 8862 CR 1258 to see if he could make contact with anyone.
3. Deputy Paiz made contact with an Abby Alaniz who told Deputy Paiz the horse did not belong to her. Alaniz told Deputy Paiz the horse would show up to her house multiple times and would try to get in the fenced in area with her horses. Deputy Paiz asked Alaniz if she knew who the owner was and she replied no.
4. Alaniz told Deputy Paiz there was a white house that looked like a building two streets down and she believed that is where the horse belonged. Deputy Paiz asked if she knew the person's name and she said no. Deputy Paiz went to the home to see if he could make contact with anyone but no one was home. There was also no mailbox nor address at the home.
5. Deputy Paiz then asked dispatch to contact Fallen Horse Rescue to pick up the horse. Jessica Brower and Elizabeth Stich with Fallen horse Rescue arrived and was able to catch the horse and hold it until Mike Johnson with Fallen Horse Rescue arrived and took possession of the horse. Deputy Paiz then cleared the call.

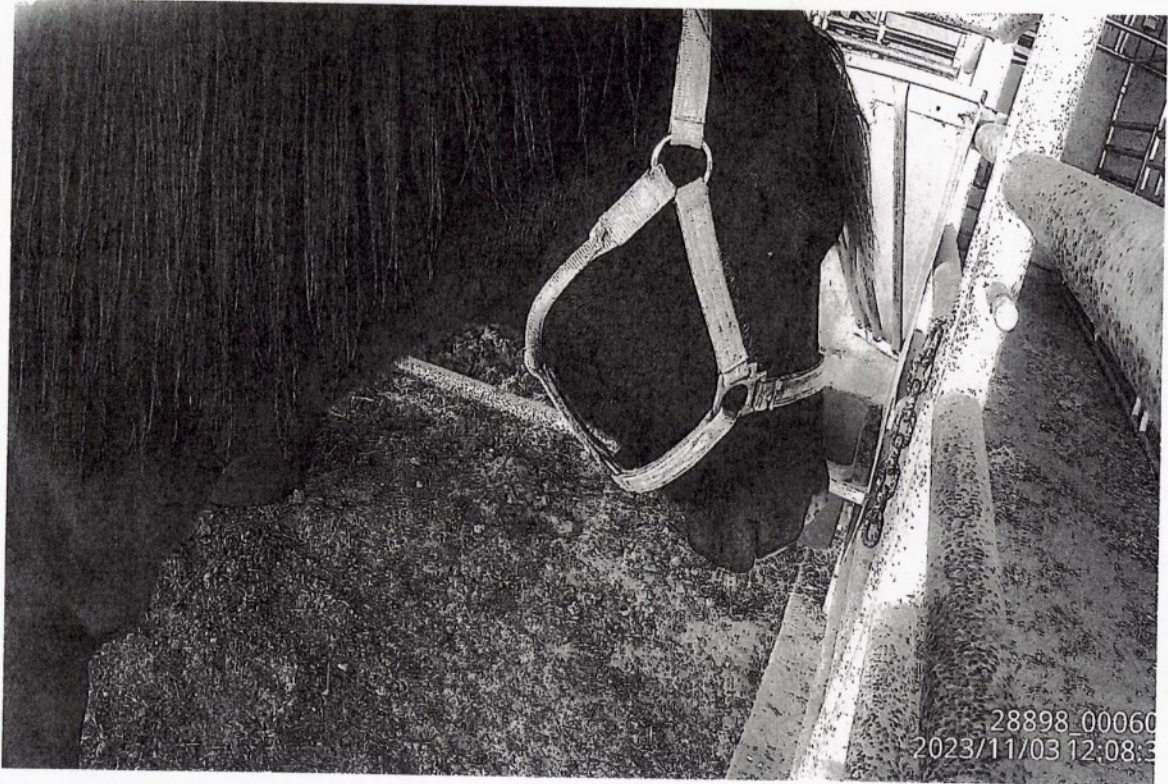




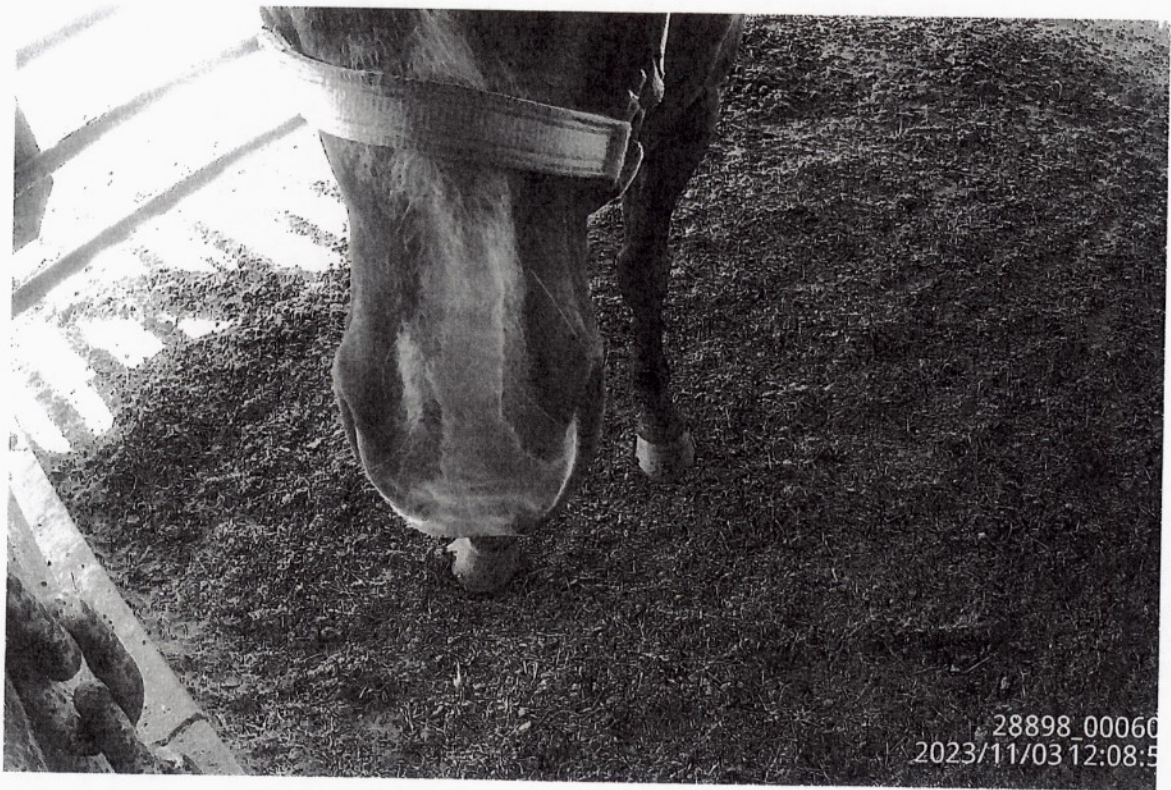
